

Individual - Self Certification Form (CRS) 個人 - 自我證明表格 (共同匯報標準)

Please read these instructions before completing the form.

Regulations based on Organization for Economic Co-operation and Development ("OECD") Common Reporting Standard ("CRS") require Getta Gold¹ to collect and report certain required information based on an individual account holder's tax residency status. 根據經濟合作與發展組織 (簡稱「經合組織」) 的共同匯報標準 (簡稱「CRS」) 的規定, 皆得金業¹ 必須根據個人帳戶持有人的稅務居住地蒐集及匯報所需相關資料。

Each jurisdiction has its own rules for defining tax residence. In general, tax residence is the country in which you live. Special circumstances (such as studying abroad, working overseas or extended travel) may cause you to be resident elsewhere or resident in more than one country at the same time (multiple tax residency).
